## Sailing Instructions

**Rules**: The regattas in both these series will be governed by the rules as defined in the current *Racing Rules of Sailing, unless* specifically changed in these instructions.

**Entries**: Competitors may enter a series by delivering a completed <u>Owner's Declaration</u> - www.j80.org/J80appdx.pdf and the \$35 per series (\$45 for non-US Sailing members) entry fee to Jon Rochlis, 112 Varney Point Rd. Left, Gilford, NH 03249. Please make checks payable to the *Lake Winnipesaukee Sailing Association (LWSA)*.

**Notices to Competitors:** Notices to competitors will be posted on the official notice board located at <u>www.lwsa.org/J80notices</u>, and/or e-mailed to the owner/skipper list.

**Changes in Sailing Instructions:** Any change to these sailing instructions will be posted and/or e-mailed to the owner/skipper list before 1200EDT on the day it will take effect.

**Signals Made Ashore:** In the event a regatta must be cancelled, the organizing authority will post a cancellation notice on the notice board. If not posted, or if the cancellation occurs after 1200EDT on a regatta day, efforts will be made to call and/or email all registered skippers. Should the race committee find it necessary to postpone, abandon or use the alternate racing area on a regatta day, they will broadcast a notice to competitors on the VHF radio (Ch 72) no later than 1745 EDT.

**Schedule:** The warning signal for the first race will be at 1800EDT on each regatta date. Subsequent races in a regatta will be held as soon as possible after the end of the previous race. No race will be started after sunset. The regatta dates are as follows:

Spring Series:	May 26, June 2, 9, 16, 23, 30
Summer Series:	July 7, 14, 21, 28, August 4, 11 (Aug. 11 <sup>th</sup> warning at 1730 EDT)

**Racing Area:** Racing will be held on *Lake Winnipesaukee*. The primary racing area will on the *Broads*, southwest of *Welch Island*. However, the race committee may choose to use *Sander's Bay* as an alternative racing area.

**Course:** The course will be windward/leeward. The windward and leeward marks will be rounded to port. The leeward mark will be the pin end of the start/ finish line. The default number of legs shall be four; however the race committee may designate any

number of legs by hail or visual signal no later than the warning signal for the next race. An odd number of legs will mean a windward finish.

**Marks:** The race committee reserves the right to use whatever marks may be available. A race committee boat may be used as a replacement of a missing or out of position mark. An RC boat acting as the replacement mark will display flag M and make repetitive sound signals.

**The Start:** Races will be started by using rule 26 with the warning signal given five minutes before the starting signal. A J80 Class flag or yellow flag will be used as the warning flag. The starting line will be between a staff displaying an orange flag on a race committee boat and a nearby mark. A boat starting later than five minutes after its starting signal will be scored *Did Not Start*. This changes rule A4.1.

**Change of the Position of the Next Mark:** To change the position of the next mark, the race committee will move the original mark (or the finishing line) to a new position. The change will be signaled before the leading boat has begun the leg, although the mark may not yet be in the new position. Any mark to be rounded after rounding the moved mark may be relocated without further signaling to maintain course configuration.

**The Finish:** The finishing line will be between a staff displaying an orange flag on a race committee boat and a nearby mark. In the absence of the race committee, a boat shall take its own finish by noting the boat that finishes previous and subsequent to it as well as the time and report to the race committee as soon as possible. If there is no longer an established finishing line, a boat shall finish as close to the remaining mark as practicable on a line extending from the required side at a 90 degree angle to the last leg.

**Penalty System:** Rule 44.2 is changed so that the Two-Turn Penalty is replaced by a One-Turn Penalty, which must include one tack and one jibe in the same direction.

**Time Limit:** Boats failing to finish within fifteen minutes after the first boat sails the course and finishes will be scored *Did Not Finish*. The race committee may hail the boat on the radio. A boat so hailed will be given five minutes to get to the starting area before the warning signal for its next race. Use of the motor to return to the starting area is encouraged in the interest of expediency and may be used up until one minute before the start as long as the returning boat remains on the course side of the start line. This changes rules 35 and A4.1.

**Navigation Lights:** Class rules require a battery and working navigation lights. Any boats in or near the racing area after sunset must illuminate their navigation lights. Boats not so illuminating their navigation lights are subject to protest. Reference rule 48.

**Motors:** All boats must carry the class-required outboard motor mounted to the transom at all times.

**Protests:** The purpose of the One-Turn penalty provision is to reduce or eliminate off the water protests. Adjudication of protests is difficult and inconvenient for all parties,

including those disinterested parties who need to assemble to hear the protest. The following protest protocol will be used:

**All protests must be properly initiated.** This includes immediate hail and display of the protest flag, display of the flag at the finish and prompt notification of the race committee prior to the start of the next race.

**Protests must be written on <u>official protest forms</u> available from US Sailing.** Protests must be mailed to Ted Baker, P.O. Box 533, Waterville Valley, NH 03215-0533 postmarked no later than the day after the incident. Alternatively, a *.pdf* file of the completed protest form may be emailed to tbaker.wv@boothcreek.com no later than 1800EDT hours the day after the incident. A copy of the protest must also be sent to the protested party(s) on the day after the incident.

**Protest hearings** will be held at fleet meetings scheduled for the following dates:

Spring Series:	June 14 and July 5
Summer Series:	August 2, August 23

The fleet meetings will be held in the sail loft at Fay's Boatyard and will start at 1830EDT.

**The parties may agree to an alternate penalty at any time after the race.** The penalty will be a scoring penalty equal to one third of the number of the boats competing in the race rounded up to the next whole number. Both parties must sign a letter to the fleet captain informing him of the agreement.

Scoring: The low point scoring system of Appendix A to the rules will apply.

Six races shall constitute a series. A maximum of eighteen races per series are scheduled.

The first three races of a regatta will be scored.

Each boat's series score will be the total of all its scores, discarding the worst scores, one for every four races sailed. The maximum number of discards allowed in a series will be four. This changes rule A2.

A boat that did not come to the starting area, did not start, did not finish, retired after finishing, or was disqualified shall be scored for the finishing place <u>one</u> more than the total number of boats that started or were OCS. This changes rule A4.2 and A.9.

Abandoned races will not be rescheduled unless they are essential to meet the six race minimum requirement for a series.

For a race to count in a series, a minimum of three registered boats intending to race must be in the vicinity of the starting area during one of the regatta's starting sequences.

Redress (Byes): (1) Boats providing race committee coverage may request their average points (after throw-outs) for races completed that evening. However, boats are encouraged to find extra help, leave at least one person on the committee boat, and race on their assigned race committee evenings. (2) One of the purposes of J/80 sanctioned fleets is to support Class activities, thus a boat may request it's average points (after throw-outs) for races missed due to participation in a J/80 Class World, North American or National Championship regatta, or any of the designated "Northeast Circuit" events (see below).

Boats that have not submitted an Owner's Declaration or paid the fee as stated in the Notice of Race will be scored the same as a boat that did not come to the starting area.

**Support Boats:** Friends and relatives in non-competing boats should be instructed to keep clear of the racing area and avoid verbal or physical contact with the competitors.

**Radio Communication:** The race committee will monitor and use VHF channel 72 to communicate with competitors. Note that class rules require a working VHF radio on all boats.

**Cell Phones:** For safety and organizational reasons, cell phones are allowed on board but must be off while racing.

**2005 J80 Class Events and Northeast Circuit:** The only events on the circuit that coincide with the Fleet#1 Thursday Series are:
