# Lake Winnipesaukee Sailing Association Notice Of Regatta

### Winnipesaukee Open One Design (W.O.O.D) Regatta and Ultimate 20 Northeast District Championship June 10 & 11, 2000

**Invitation:** The Lake Winnipesaukee Sailing Association (LWSA) and the Winnipesaukee Yacht Club (WYC) are pleased to invite all sailors to the sixth annual W.O.O.D. Regatta, and the Ultimate 20 Northeast District Championship.

**Eligibility:** The Regatta is open to any skipper or owner who wishes to participate. Participants must meet all Regatta requirements, and must have paid all event fees and have completed an official entry form and waiver before being recognized as official competitors. The Regatta is open to all one-design classes, and starts will be provided to each Fleet with three or more registered entrants.

**Rules:** This Category A Regatta will be governed by The Racing Rules Of Sailing (RRS) 1997-2000 *including US SAILING Prescriptions*, the class rules of each respective class association, this notice (except as to any modification by the Sailing Instructions), and the Sailing Instructions.

**Scoring:** The low point scoring system (RRS Appendix A2) will apply, except that each boats total score will be the sum of her scores for all races. The 720 degree Turns Penalty, RRS Rule 44.2 shall apply.

**Launching/Moorings:** Launching will be available at Fay's Boat Yard, 71 Varney Point Road, Gilford, NH on Friday June 9, between 0800 and 1700 and by appointment. Moorings will also be available at Fay's. To arrange for launch or mooring contact Brian Richardson at 603.293.8000.

**Entry:** Each entry must be submitted on the form attached hereto (fax or photocopy will be accepted). The entry fee is \$40.00 (\$35.00 for USSA members) by cash or check payable to Lake Winnipesaukee Sailing Association. All net proceeds benefit the LWSA youth sailing program.

**Site:** Racing will take place on Lake Winnipesaukee in the area known as "The Broads" or the area known as "Saunders Bay".

**Fleets**: Each Fleet shall consist of no fewer than three boats of a one-design class. Each Fleet shall be responsible to assure that its own class rules are enforced. Each Fleet entering the Regatta shall designate a Fleet Representative to coordinate events with the Regatta Chair or, where appropriate, the PRO. Class registration by the Fleet Representative may be accomplished at any time until 0900 Sat June 10. Regatta organizers anticipate providing starts for U20, J/80 and J/24 Fleets, and welcome registration of additional one-design classes.

**Prizes**: Prizes will be awarded to the top finisher in Fleets of three boats, the top two finishers in Fleets of four or five boats, and the top three finishers in Fleets of six or more boats. The top finishing Ultimate 20 will be recognized as the class Northeast District Champion.

**Social:** An awards ceremony will be held at WYC, Dockham Shore Road, Gilford, NH, immediately following the last race.
