Prizes: Prizes will be awarded to the top finishers in fleets of three or four boats. Prizes will be awarded to the top three finishers in fleets of five or more boats.

Racers get there first two cookout tickets with their entry fee additional tickets are \$5, Cookout tickets for non racers are \$7.
