Invitation: The Winnipesaukee Yacht Club is pleased to invite all sailors to the 2006 Commodores Cup Regatta

Eligibility: This Regatta is open to any skipper or owner who wishes to participate. Participants must meet all regatta requirements, and must have paid all event fees before becoming official competitors.

Rules: This Regatta will be governed by the 2005-2008 *Racing Rules Of Sailing* (RROS) *Including US SAILING Prescriptions*, this notice (except as to any modifications by the sailing instructions), and the sailing instructions.

Advertising: This event will be a category "A" event as determined by appendix G or the RROS

Scoring: The low point scoring system (Appendix A2) will be used. The 720 degree Turns Penalty, Rule 44.2 of the RROS, shall apply.

Launching/Hauling: Launching will be available at Fays Boatyard, Gilford, NH on weekdays between 8:00AM and 5:00PM and by appointment. Moorings will also be available at Fays by appointment. The cost of launch and mooring is not included in the entry fee. To arrange for launch or moorings contact Fays at (603)293-8000.

Entry: Each entry must be submitted on the form attached hereto (photo and fax copies will be accepted). The entry fee is \$35.00 (\$30.00 for USSA members) by cash or check payable to Winnipesaukee Yacht Club (WYC).

Site: Racing will take place on Lake Winnipesaukee in a location to be determined by the race committee which may include one of the following locations:

- A. The Area Known as "The Broads"
- **B.** The area known as "Sanders Bay

Contact: Entries will be accepted on race day.

Prizes: Prizes will be awarded to the top finishers in fleets of three or four boats. Prizes will be awarded to the top three finishers in fleets of five or more boats.

Social: A Bar-B-Q will be available on Saturday evening after the last race of the day. The awards ceremony and a cookout will be held at the WYC immediately following the last race on Sunday.
