Invitation: The Winnipesaukee Yacht Club is pleased to invite all sailors to the 2014 Season Ending Cold Duc Race.

Eligibility: The race is open to any skipper or owner who wishes to participate. Participants must meet all race requirements, and must have paid all event fees before becoming official competitors.

Rules: This regatta will be governed by the 2013-2016 *Racing Rules Of Sailing* (RROS)*Including US SAILING Prescriptions*, this notice (except as to any modifications by the sailing Instructions), and the sailing instructions.

Scoring: The low point scoring system (Appendix A2) will be used. The Two Turns Penalty, Rule 44.2 of the RROS, shall be replaced and a One Turn Penalty shall apply.

Entry: Each entry must be submitted in the form attached hereto (a photocopy will be accepted). The entry fee \$35.00 (\$30.00 for USSA members) by cash or check payable to Winnipesaukee Yacht Club (WYC).

Site: Racing will take place on Lake Winnipesaukee, and will be an island course for all classes. We may have sl courses for smaller boats depending on the number of registrants
