Invitation: The Lake Winnipesaukee Sailing Association is pleased to invite all sailors to participate in a double-handed sailboat race.

Eligibility: This Series is open to any skipper or owner who wishes to participate. Participants must meet all event requirements, must fill out and submit the attached entry form and must have paid all event fees before becoming official competitors. Entry forms may be submitted to the event coordinator at any time.

This is a double-handed race for husband and wife teams. This includes significant others and non-traditional spouses. No more than two people may be aboard the boat with the exception of non-participating children or elderly family members of the crew members. In keeping with the lighthearted nature of this race, teams consisting of other than a man and a woman, or non-spouses/significant others will be assigned a significant non-contestable handicap by the event coordinator.

Rules: This Series will be governed by the 2013-2016 Racing Rules Of Sailing (RROS), US Sailing prescriptions, this notice (except as to any modifications by the sailing instructions), and the sailing instructions.

Scoring: Current NE PHRF ratings will be used to determine reverse handicap starting order via the Time on Distance method. If you do not have a valid NE PHRF rating, the event coordinator will assign a temporary non-contestable rating.

Entry: Each entry must submit the form attached to this notice to the event coordinator. This may be done at the Skippers meeting. There is a \$10 entry fee for this race and each team is required to make an appearance at the post race party at the new Sailing Center on Smith Cove.

Site: Racing will take place on Lake Winnipesaukee around Welsh Island. The start and finish will be designated by two buoys near Diamond Island. This plan may be modified by anticipated wind strength and direction on race day. The exact course and other sailing instructions will be announced at the Skippers Meeting.

Skippers Meeting will be held at 10AM on August 9th. The Skippers Meeting will be at Fays on the steps to the old sailing school.

Starts will be reverse handicap as determined by PHRF rating. Start times will be assigned at the Skippers meeting. GPS time is the standard. The first start time will be at noon.
