Rules: This regatta will be governed by the 2013-2016 Racing Rules Of Sailing (RROS) Including US

SAILING Prescriptions, this notice (except as to any modifications by the sailing Instructions), and the sailing instructions.

Scoring: The low point scoring system (Appendix A2) will be used. The Two Turns Penalty, Rule 44.2 of the RROS, shall be replaced and a One Turn Penalty shall apply.

Entry: Each entry must be submitted in the form attached hereto (a photocopy will be accepted). The entry fee \$45.00 (\$40.00 for all WYC and LWSA members) by cash or check payable to Winnipesaukee Yacht Club (WY

Site: Racing will take place on Lake Winnipesaukee, and will be an island course for all classes. We may have sh courses for smaller boats depending on the number of registrants

The undersigned also represents that he/she and any crew permitted aboard the boat are experienced and competent, are physically fit, and capable of swimming or treading water in full sailing attire, and have been instructed in the use and location of all safety equipment aboard the boat.

The undersigned acknowledges that the decision to start and/or continue racing is the sole and exclusive responsibility of the undersigned.

In consideration of the acceptance of this entry, the undersigned certifies that each of the foregoing statements and representations are true and accurate and, on behalf of himself/herself and his/her heirs, successors and assigns, hereby releases and forever discharges The Winnipesaukee Yacht Club and the Lake Winnipesaukee Sailing Association and their respective members, volunteers, employees, agents, Officers, Board of Directors, Race Committees and Juries from any and all liability arising out of my participation in this regatta and all social events connected therewith, whether such loss is due to property damage, personal injuries or loss of life, even if such loss is due to the negligence of any party so released.
